The purpose of AHC's Strategic Plan is to set and document long-term goals and strategies for the organization. 

CELEBRATING 45 YEARS!

For the past 45 years, AHC has served the needs of northern Michigan regardless of a patient's ability to pay for services.

We strongly believe that all people have the right to high-quality healthcare. Our goal is to remove barriers to care and provide high-quality, evidence-based care in a place that is convenient. We believe everyone deserves to be treated with dignity and respect.

Opening in Lincoln, Michigan in 1978 and serving as the only means to access healthcare in Alcona County, over the decades AHC has grown to operate 14 primary care facilities, three school-based clinics, a school wellness program, 19 school based behavioral health locations, two dental clinics, two remote hygiene clinics and two pharmacies. AHC is also the umbrella agency for



AHC is a non-profit, federally qualified health center (FQHC) that provides high-quality medical, dental, behavioral health and pharmacy services to families and individuals of all ages. AHC offers a Sliding Fee program which allows a discount on fees based on family income and size, for the care received at any AHC location. AHC staff can assist with insurance enrollment options and/or applying for sliding fee.

Today, AHC meets the needs of communities across six northern Michigan counties, serving more than 34,000 patients annually. We have remained focused on the long-term health of our communities through the provision of care and our community programming that helps address our patient's socioeconomic needs.

We expect to continue to grow and bring new jobs to our economy while providing a healthcare home to more people in our service area. Our goal is to provide a healthier future for all families.



PROVIDING OUR COMMUNITES WITH INTEGRATED HEALTHCARE

In a Patient Centered Medical Home (PCMH) model, the patient has a relationship with their primary care provider (PCP) who recognizes that each of them has unique needs, cultural values and preferences. Patients will experience greater satisfaction with the care they receive, and a greater likelihood of better health outcomes.

The PCP is not the only person taking care of a patient's health needs. The PCP is part of a care team with the same goal in mind, to take care of patients both mentally and physically. This team includes the PCP, the patient, and other healthcare providers and support staff. The integrated healthcare team works together to help reach the patient's health goals.

With the PCMH model at AHC, patients can take advantage of better access to care, and less waiting time for appointments and test results. Also, patients with a chronic condition such as diabetes or high blood pressure, have regularly scheduled appointments that allow the care team the opportunity to monitor, educate, and adjust the care plan as needed.

In summary, PCMH at Alcona Health Center is a partnership among practitioners, patients and their families. A team of healthcare providers is accountable for their patients' physical and mental health care needs organized across all elements of the healthcare system with a commitment to quality and safety.

PATIENT SUPPORT SERVICES

At AHC we do whatever it takes to help patients overcome barriers to healthcare - cost, time, transportation, language. As an important part of our care team, our patient support staff help patients apply for services or resources in our communities, from insurance enrollment to assistance with daily needs – food, housing, transportation, education, and more. We are dedicated to bringing wellness to life for everyone living in northern Michigan.



Community Health Worker, Tamara Pasnev from our Cheboygan Campus helps address social determinants of health, such as transportation or food insecurity. She also assists patients with insurance coverage and access to care issues.



Care Manager, Andrea Noble, LPN assists patients in our Recovery Services Program.


She offers support through health education and assists patients with setting and obtaining achievable health goals throughout their recovery journey.



Dental Care Connector, Nancy Losinski reaches out to our patients who have had recent emergency room visits to ensure that they have any follow-up care they need. She also contacts patients who have had gaps in care to assist them get back on track with their oral health.

SCHOOL BASED CARE

AHC School Based Care locations provide integrated, holistic health services and build connections within the community and schools to promote student health, well-being, and school success. Establishment of School Based Care is a partnership between a school, parents, and a sponsoring agency, such as AHC. Within a School-Based Health Center (SBHC), medical and behavioral health services are provided by licensed professionals. The program also requires establishment of a Community Advisory Council, made up of school staff, parents of school-aged children or adolescents, school health representatives and clinicians from AHC.





Benefits of School Based Care

Removes barriers to accessing healthcare services, such as transportation and same day appointments.

Students can be seen at school during the school day, missing less class, and parents/guardians do not need to miss work. (Parental consent is required except when excluded by law.)

SBHC services are provided to all students at low or no cost, regardless of insurance status and all students are welcome to use clinic services.

In 2023, 1,214 students were seen for School Based Care through 7,125 visits, primarily for medical and behavioral health services.



CHILDREN'S ADVOCACY CENTER

The Children's Advocacy Center of Northeast Michigan (CACNEMI) serves our region by providing comprehensive services to victims of child abuse and their families. Services of advocacy, forensic interviewing, trauma counseling, and sexual assault medical examinations each support the goal of empowering children to find their voice and the vision of eliminating child abuse. The CACNEMI uses a "child first approach" meaning the professional will always consider the child to be the main priority.

The CACNEMI was established in December 2012 and operates under the AHC umbrella, primarily serving Alcona, Alpena, Montmorency and Presque Isle counties. The CACNEMI is a child-friendly, neutral facility helping abused children by providing a safe place to receive team-based, comprehensive, coordinated services from dedicated professionals. The CACNEMI has been accredited by the National Children's Alliance since 2013.









2023 ACHIEVEMENTS

QUALITY AWARDS

AHC received the Health Resources and Services Administration's (HRSA) badges for Advancing Health Information Technology (HIT), Health Center Quality Leader, and the badge for National Committee for Quality Assurance (NCQA) Patient Centered Medical Home.

Advancing HIT

Met criteria to optimize health information technology services that advance telehealth, patient engagement, interoperability, and collection of social determinants of health to increase access to care and advance quality of care.

Health Center Quality Leader

Achieved the best overall clinical quality measure (CQM) performance among all health centers. AHC received bronze level for being in the top 21-30 percent.

Patient Centered Medical Home (PCMH)

Hold NCQA PCMH recognition in 14 delivery sites. The HRSA badges specifically outline AHC performing in the highest tiers of various quality metrics-all of which directly show patients how AHC is leading the way in quality care.

OPERATIONAL SITE VISIT

In September 2023, AHC participated in a three-day Operational Site Visit (OSV) conducted by the federal HRSA. OSVs are conducted every three years and are designed to perform a full organizational assessment in all operational areas (fiscal, clinical, administration/governance). AHC was pleased to have demonstrated full compliance with the federal Health Center Program. The surveyors were very complimentary of our organization, staff and board members.

New Location - Alpena Pediatrics

2023 saw the completion of a new 6,400 square foot pediatrics center in Alpena. The facility is an expansion of the existing Alpena campus. This new location will house a pediatrician, child and adolescent psychiatrist and a nurse practitioner who can partner with families to understand their child's health, medical and behavioral needs, challenges, and goals.

Pharmacy Services

The AHC pharmacies in Alpena and Lincoln values the community and is here to provide friendly and convenient service to our patients. As the demand for prescription services continues to grow, 2023 saw the addition of a drive-through window at our Lincoln in house pharmacy. The Alpena drive-through has been successful for many years.

The AHC drive through pharmacies allows patients to pick up their prescriptions, from the comfort of their vehicle. We are here to increase access to patients and the public who are relying on us for fast and convenient service.


Richardson Elementary School - Owl Clinic Space

Alpena High Health Center


We completed renovations in this location and the site is fully operational.



FAMILY MEDICINE RESIDENCY

AHC's family physician residency program is a three year, post graduate training program committed to fostering compassionate and competent physician leaders within our community. Our primary objective is to develop exceptional family physicians dedicated to providing high-quality care.

Launched in 2021, our residency program is affiliated with the MyMichigan Midland Family Medicine Residency Program and the Michigan State University College of Human Medicine. Our family medicine residency emphasizes training family physicians in the full-spectrum care of a diverse patient population while experiencing the realities of practicing in a rural setting. Research indicates that physicians who train in underserved areas are more likely to practice in similar settings after graduation.

The program is part of Michigandocs.org (MIDOCs), a state-funded program designed to expand graduate medical education residency positions and retain physicians in underserved areas in the state of Michigan. The first two residents to participate in the program are Christian Grant, MD and David Westphal MD, who both made the decision to remain with AHC following graduation in 2024.

AHC's Family Medicine Residency program is made up of hard-working and dedicated individuals who wish to provide care to patients in a rural setting. We have six physicians currently enrolled in our program:

ON-THE-JOB LEARNING OPPORTUNITIES

We offer apprenticeship programs—for medical assistant, dental assistant, community health worker, and pharmacy technician. These earn-while-you-learn programs are all-encompassing, including classroom instruction, supplies, and hands-on training. Once successfully licensed or certified, participants transition to positions within our clinics.
